- Contractor registered with Central Government / any State Government of any PSU or an agency of national reputed may participated in e-tender without the registration. However, registration with the concerned works department will be essential after issue of L.O.A.

Following documents are required at the time of submission of bid (in case of other State PWD/CPWD/ any PSU eligible contractors or Agencies of National reputed following documents (from a to c) have to be submitted after letter of acceptance).

- Registration paper (renewed) of appropriate class and deptt.
- GST registration .
- Latest labour license (renewed) in State of Bihar.
- Power of attorney/ Partnership deed/ MOU of private limited company.
- Bank Draft for B.O.Q. cost. (Amount as per column 7 is payable through bank draft issued from nationalised bank in the favour of executive engineer, RWD, Works division, Darbhanga-1 payable at Darbhanga. Other mode of payment is not acceptable.)
- Tools & plants ownership/ lease certificate required in aforesaid work duly verified from Divisional Engineer/ other State PWD/CPWD Contractor will provide definite proof from appropriate authority for tools & Plant and Undertaking to install it on works site after getting letter of acceptance).
- SL.No 1 is reserved for unemployed engineer .
- Contractors registered under class –IV only can take part in SL.no-nil.

Agreement shall be drawn with the successful tenderer on prescribed Form No. P.W.D. 2/3 which is available as a Govt. of Bihar Publication, Tenderer shall quote his rates as overall percentage above/below the amount of B.O.Q. or item rate as per various terms and conditions of the said which will form part of the agreement.

2. The amount of Estimated Cost or B.O.Q. Cost of the work may vary.
3. The earnest money will be applicable on the sanction cost of B.O.Q. only.
4. The time allowed for carrying out the work will be mentioned in work detail day after the date of written orders to commence the work of from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
5. The site for the work is available.


6. Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose
- 7 tender may be accepted and other necessary documents can be seen in the office of the Signatory between hours of 11.00 A.M. & 03.00 P.M. from 15.01.2018 to 21.01.2018 everyday except on Sunday and Public Holidays. 8. Earnest money Pledged in favour of Executive Engineer, RWD, Works Division, Darbhanga-1 as per column no.-6 as mentioned in Bihar Financial Rule. For work costing more than one crore, Bank Guarantee from any scheduled bank in the state. ( If issued from any bank outside state then it will be converted from any bank within state before executing the work agreement)
9. The Contractor shall be required to deposit an amount equal to 2% (in case of enemployee engineer 1%) of the tendered value of the work as performance guarantee including earnest money in the form as mentioned in Bihar Financial Rules. For works costing more than one Crore, bank guarantee is acceptable.
10. The description of the work is as follows:-

Copies of other drawings and documents pertaining to the works will be open for inspection by the tenderers at the office of the above-mentioned officer.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tool & Plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

11. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
12. The competent authority on behalf of Governor of Bihar reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall bound to perform the same at the rate quoted.
13. The contractor shall not be permitted to tender for works in the RWD Division (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or

are subsequently employed by him and who are near relatives to any gazetted officer in the RWD any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.

14. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of Bihar is allowed to work as a contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of Bihar in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission to the Government of Bihar as aforesaid before submission of the tender of engagement in the contractor's service.
15. The tender for the works shall remain open for acceptance for a period of 120 days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 100 % of the said earnest money as aforesaid.
16. The Department has right to cancel or postpone any work without given any notice or clarification.
17. The Department may add or delete any of the condition required for execution of any work.
18. This Notice Inviting Tender shall form a part of the contract document. The successful tenderer/contractor, the Competent Authority, shall issue the letter of acceptance and will sign the contract within 15 days after submitting the performance guarantee:-
  - (a) The notice inviting tender, all the documents including additional conditions specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
  - (b) Standard P.W.D. Form 2/3
19. A set of bidding documents will be available online on website <http://pmgsytendersbih.gov.in> Cost of bid document non-refundable will be deposited in the form of demand draft of any schedule bank in favour of the Executive Engineer mentioned in column 7 of the table corresponding to the respective Road.
20. Bids must be submitted online on website <http://pmgsytendersbih.gov.in> on or before 03:00 PM dated 21.01.2018
21. Bids submitted online must be accompanied with scanned copy of Demand Draft of bid cost per package as part of Contractor's documents.
22. Instrument of Bid Security (in the form of Bank Guarantee or Fixed Deposit Receipt or in any other forms as specified in the bidding document) of the amount specified for the work in the table shall be valid for 45 days beyond the validity of the bid. Scanned copy of the instrument of this affidavit shall be submitted online as part of Contractor's documents.  

23. Affidavit along with Original Demand Draft of Cost of Bid Document in the form of DD and Bid Security shall be placed in an envelope and must be submitted at the office of Executive Engineer, RWD Works Division, Darbhanga-1 / Supdt. Engineer, RWD Works Circle, Darbhanga/Chief Engineer-3, RWD, Patna before dated 23.01.2018 up to 15:00 Hours of the Bid strictly observing the following conditions: -
  - (a) Contractor's WILL NOT WRITE THEIR NAMES OR THEIR FIRM'S NAME on this envelopes.
  - (b) When the contractor submits his bid online, he will get an acknowledgement of submitted bid. The number mentioned on this acknowledgement only will be mentioned on the envelop containing original affidavit, DD for Bid cost and earnest money. This is essential to maintain the confidentiality of bidder.
  - (c) Copy of acknowledgement slip ie; bid submission summary will be put inside this envelop to ensure proper identification of the bidder.
24. Online Bid Opening Date 23.01.2018 at 15:30 Hours.

25. The date and time of opening of the financial bid shall be notified on website <http://pmgsytendersbih.gov.in>. This is conveyed to the bidder automatically through an e-mail message. The Financial bids shall be opened accordingly online on the same website <http://pmgsytendersbih.gov.in> at the office of Engineer-in-Chief-cum-Secretary, Bihar Rural Roads Development Agency (BRRDA), Patna by the designated officers.

27. Five year maintenance will be done by the same contractor as per the guide lines of **PMGSY**.
28. Additional Performance Guarantee will be taken as per the departmental letter no. 32 dated 05-01-2011.
29. GST Registration will be required before Agreement from the Successful bidder only.
30. As per Notification No. 13589 dated 13.12.2011 of RCD Only those contractors who are registered under class IV can take part in the tender of work up to 25 lakhs. Contractors who are registered under class I, II, III can not participate in the tender amounting up to 25 lakhs or less.
31. As per letter No. 2046(s) dated 06-03-2014 of RCD rate Quoted below 10% of B.O.Q. Cost, their tender will be reject.
